# NON-DISCLOSURE AGREEMENT 2018 - Present

**Jacksonville Gem and Mineral Society (JGMS) and All JGMS Members (Recipient)**

**IN CONSIDERATION OF** and as a condition of JGMS providing Confidential Information to the club in addition other valuable consideration, the receipt and sufficiency of which consideration is hereby acknowledged, the parties to this Agreement – agree as follows:

**Confidential Information:**

1. All written and oral information and materials disclosed or provided by the JGMS to the Member under this Agreement is Confidential Information regardless of whether it was provided or after the date of this Agreement or how it was provided to the Recipient.
2. Confidential Information means all data and information related to the JGMS, including but not limited to the following:
  - a. "JGMS Information" which includes names of members, instructors, and students of the JGMS. All JGMS contact information, contracts and their contents and parties. JGMS service, data provided by the JGMS for the purpose of developing a relational database application.
  - b. Confidential information will also include any information that has been disclosed by a third party to the Recipient or JGMS and is protected by a non-disclosure agreement entered into between the third party and the JGMS.
3. Confidential information will not include the following information:
  - a. Information that is generally known in the industry of the JGMS.
  - b. Information that is now or subsequently becomes generally available to the public through no wrongful act of the Recipient.

**OBLIGATIONS OF NON-DISCLOSURE:**

1. Except as otherwise provided in this Agreement, the Recipient must not disclose the Confidential Information.
2. Except as otherwise provided in the Agreement, the Confidential Information will remain the exclusive property of the JGMS and will only be used by the recipient for the Permitted Purpose. The recipient will not use the Confidential Information for any purpose that might be directly or indirectly detrimental to the JGMS or any of their affiliates or members.

**NON-SOLICITATION:**

1. The recipient agrees that from the date of this Agreement will not in any way, directly or indirectly use the client's data provided to the JGMS for the purposes of soliciting member to purchase or use any product or services.
2. All communications with the members will only be with approved contacts identified by the client and at the direction of the JGMS for the purposes of providing JGMS service and technical support.

**RETURN OF CONFIDENTIAL INFORMATION:**

1. The Recipient agrees that, upon request of the JGMS, or in the event that the Recipient ceases to require use of the Confidential Information, or upon the expiration or termination of this Agreement or the expiration or termination of this project, the Recipient will turn over to the Recipient all confidential material in their possession or control of the Recipient.
